#### **University Publishes Academic Calendar for the** Academic Year 1446H - 2025/2024

The Media Center at the university has published the academic calendar for the academic year 1446H 2025/2024 through its affiliated Media Center.

The new calendar includes four main sections that provide important information about the first semester, second semester, and summer semester, in addition to registration dates for the new academic year.

According to this calendar, actual classes will begin in the first semester on Saturday, 7th of Muharram 1446H, corresponding to July 13th, 2024, and will continue until the conclusion of examinations on Wednesday, 27th of Rabi' al-Thani 1446H, corresponding to October 30th, 2024. As for the second semester, it will commence on Saturday, 14th of Jumada al-Awwal 1446H, corresponding to November 16th, 2024, and examinations will end on Thursday, 28th of Sha'ban 1446H, corresponding to February 27th, 2025. The summer session will start on Saturday, 7th of Shawwal 1446H, corresponding to April 5th, 2025, and its examinations will conclude on Wednesday, 1st of Dhul-Hijjah 1446H, corresponding to May 28th, 2025.

It is worth mentioning that the registration for the first semester of the new academic year has already opened, starting from Saturday, 25th of Shawwal 1445H, corresponding to May 4th, 2024, and will continue until Friday, 27th of Muharram 1446H, corresponding to August 2nd, 2024.


