The Islamic University of Minnesota has announced three new offers for students wishing to enroll in the second semester of the 2025-2024 academic year / 1446 AH.

The first offer allows for the installment of tuition fees. This ongoing offer enables students to pay a single installment of



Engineer Ali Mustafa, Deputy Director of the Information Technology Deanship at the Islamic University of Minnesota, announced that the launch date for the new academic system portal is set for the beginning of next year, specifically on Wednesday, January 2025, 1.

Engineer Ali added that work is ongoing to complete the new portal, with the IT team focused on the finest details. He indicated that the development of the Control Affairs and Student Affairs units, the Virtual Rooms and Registrations unit, and the Faculty Affairs Deanship has been completed, while work is currently underway on the finance system.

the registration fee, while the remaining installments will be distributed over the subsequent semesters.

The second and third offers, however, are entirely new. The second offer provides a discount of 100\$ for each student who registers alongside a sibling or a friend. The third offer includes a waiver of equivalency fees for any academic stage; these fees will be deducted from the total tuition fees if the student wishes to proceed with the equivalency process.

It is worth noting that enrollment for the second semester remains open until the start of actual classes, which are scheduled to begin according to the academic calendar on November 2024 ,16, corresponding to 14 Jumada al-Awwal 1446 AH.

These offers represent a great opportunity for students to enhance their educational journey.

Regarding the features that the new portal will provide, Engineer Ali confirmed that it will integrate all academic electronic services, including links to lectures, lecture schedules, and examination services. He also highlighted the automated grading feature for exams, whereby students' grades will be sent immediately after completing the test.

Release of the Seventh Issue of the Peer-Reviewed Academic Journal



On Saturday, September 2024, 28, the seventh issue of the second volume of the quarterly of Education in Al-Salt from the Perspective of Public School Principals. peer-reviewed academic journal, "Minnesota International Journal of Academic Studies," was released, which is based at the Islamic University of Minnesota.

The issue comprises 531 pages and contains 15 peer-reviewed research papers, most of which are published in Arabic, with two papers in English. These papers were prepared by 18 researchers from 8 countries, including the UK, Iraq, Libya, Egypt, Saudi Arabia, Jordan, Canada, and Sudan.

The issue covers a diverse range of academic research fields, including administration, health, jurisprudence, education, social sciences, language, law, and artificial intelligence, which accounts for a third of the research (five papers). These papers are the result of the conference on artificial intelligence and its Sharia applications, organized by the university in collaboration with the Tahri Mohammed Bechar University in Algeria in February 2024, according to Dr. Nourhan Salama, the chair of the organizing and preparatory committee and the conference's secretary-general.

Dr. Abdu Nasr Abdul Wahab is responsible for the editorial secretariat. The editorial team includes 43 academics, along with five senior advisory board members. The journal has an online platform on the university's official website that allows browsing and downloading of the research papers.



Islamic Studies College Publishes the First Issue of the Peer-Reviewed Journal



On Thursday, October 2024 ,17, the Islamic Studies College at the Islamic University of Minnesota published the first issue of the first volume of the peer-reviewed journal "Journal of Islamic Studies."

This issue consists of 143 pages and includes, in both Arabic and English, a message from the editor-in-chief, an overview of the journal, its vision, mission, and objectives, along with lists of the editorial board, the advisory and supervisory committee, the advisory committee, and the referees. It also contains the publication rules and guidelines for the journal.

The issue features three academic papers: the first, titled "Exploring the Relationship Between 'Taqreeb Al-Nashr' and 'Tayyibat Al-Nashr' by Imam Ibn Al-Jazari (d. 833 AH) - A Comparative Study," by Dr. Bashar Mustafa Zakaria Aytani from Saudi Arabia. The second paper is titled "Therapeutic Cloning Between Medical Laws and Sharia Evidence." by Dr. Ahmed Mohammed Mussein Moweid from Egypt. The third paper is titled "Belief in Revealed Books and Its Impact on Combating Pandemics - The Quran as a Model," by Dr. Mohammed Ibrahim Sagr from Malaysia.

The editorial board of the journal includes the editor-in-chief, Dr. Abdulrazzaq Al-Bakri, Associate Professor of Quran and its Sciences and Dean of the Islamic Studies College; the deputy editor, Dr. Ahmed Labib, Associate Professor of Applied Quranic Linguistics; and the editorial secretary, Dr. Fatima Jumaa Al-Wahsh, Associate Professor of Figh and its Fundamentals and Head of the Arabic Islamic Studies Department.

The advisory and supervisory committee of the journal is chaired by the university's vice president, Dr. Omar Ahmed Al-Magrami, with the vice dean, Dr. Zainab Ali Basyouni, and the Director of the Scientific Research Unit, Dr. Faiza Mohammed Khattab, serving as vice-chair. It also includes five other faculty members. The advisory committee consists of eight faculty members from the Islamic Studies College, chaired by Dr. Abdulrazzaq Al-Bakri. The journal has a refereeing committee comprising twenty faculty members, including six external referees.

It is noteworthy that with this publication, the Islamic Studies College has outpaced other colleges that plan to issue their own peer-reviewed journals after obtaining official licensing from the university administration.




Approval of Research Plan for Researcher Salma Al-Subaei

Comprehensive Course in Simplified Jurisprudence

It is noteworthy that the Dawah Center recorded the lecture and uploaded it to the Islamic University of Minnesota's YouTube channel.




Dawah Center Hosts Interactive Lecture


