Eighth Issue of Minnesota International Journal of Academic Studies Released

Minnesota, January 2025, 7 - The Islamic University of Minnesota - Main Center has published the eighth issue (Volume 2) of its quarterly peer-reviewed Minnesota International Journal of Academic Studies. Released on Tuesday, January 2025 ,7, the issue spans 566 pages and features 14 peer-reviewed research papers, including 11 in Arabic and 3 in English, authored by 19 researchers from 10 countries.

Professor Hanan Sobhi Obeid, Editor-in-Chief of the journal, highlighted that the research papers cover diverse fields such as strategic planning, digital media, tourism development, national identity enhancement, cybersecurity measures, environmental and narrative heritage, Islamic political thought, human resources in the digital transformation era, academic performance quality, psychological resilience, therapeutic strategies, planning skill development, and the relationship between spiritual purification (Tazkiyah) and Quranic themes.

Professor Obeid emphasized that all research papers underwent rigorous peer review by internal and external specialists, who were honored with certificates of appreciation. She also praised the outstanding collaboration between the Media Center and the editorial team, noting that the issue was completed on schedule in accordance with the strategic plan.

The journal boasts an advisory board of 48 professors and doctors, and an editorial board of 49 academics from various academic ranks. It has obtained the international serial number (E: ISSN: 9122-2994) and aspires to achieve global recognition through initiatives to twin with other Arab and international peer-reviewed journals, aiming to be indexed in Scopus.

The issue was published electronically with an elegant design by Jordanian graphic engineer Abdullah Daras, under the supervision of the Media Center Director, Engineer Abdullah Mohammed Al-Mansoub.

The unit urged faculty for the final exams of the second semester, which will be held on February members to monitor grade submissions before the deadline 2025,17. This announcement was made in an official circular issued by the In a related matter, on Saturday, December 2024, 28, students of the Control Affairs Unit to faculty members and department heads, calling on all second semester from all university departments undertook mid-semester departments across all colleges to prepare early for the exams.

The Control Affairs Unit requested that professors prepare the exams and submit them in Word format to the department head, explaining the method for drafting questions, answering them, as well as the grading distribution and required grade values. A guestion template was attached, along with the data that needs to be filled out by the course instructor, with February 7 set as the final deadline for submitting exams.

In anticipation of the exam date, the Technical Support Unit published a password to access the electronic system portal, allowing them to monitor video explaining how to upload required tasks from students via the assignments, exams, and grade submissions through the university's academic system portal on the university's official website, including how

exams, which lasted for a full week before the resumption of classes. The exams were conducted over two hours, from 8 PM to 10 PM Mecca time, with each department's secretary sending the exam link to students through the course's WhatsApp group. After the exam, the secretary forwarded the answers to the professors for grading, while the course instructor handled the grading for essay exams.

It is noteworthy that each professor has a unique academic number and electronic application.
