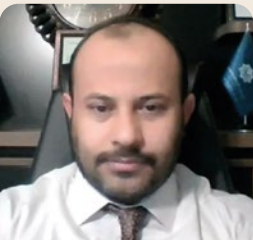

### Vice President Emphasizes Attendance and University Achievements at Student Reception

Minnesota, USA - During a reception for new and returning students, Dr. Omar Ahmed Al-Maqrami, Vice President of the Islamic University of Minnesota, emphasized the importance of student attendance in lectures, stressing that it is a fundamental condition for the university to fulfill its responsibilities. He stated that the university will not tolerate students being penalized due to absence.

Al-Maqrami noted that the university provides videos of lectures and academic materials through the electronic academic portal, facilitating students' ability to keep up with their studies, especially for those facing challenges due to time zone differences.

He also addressed the issue of delays in receiving graduation certificates, explaining how to invest time to expedite the delivery of certificates to graduates. He confirmed that

the university has obtained licensing from the Minnesota state authorities, stating that its certificates are recognized by foreign ministries and embassies.

The Vice President praised the efforts made by the university to achieve full accreditation, affirming that the university is "on the right track" and that it is merely a matter of time. He discussed the messages received from Saudi higher education authorities regarding the equivalence of certificates, confirming that students with university degrees work in both governmental and private institutions.

He concluded by emphasizing that the true measure of the university is the quality of its educational services and the research activities it hosts, highlighting the significant achievements the university has accumulated over the years.

### Start of the First Semester



Minnesota, USA - Thousands of students at the Islamic University of Minnesota headed to hundreds of classrooms across dozens of academic departments within eight colleges, marking the beginning of the first semester of the new academic year 1447 AH / 2026 CE.

This launch was preceded by intensive efforts, starting with the announcement from the Admissions and Registration Deanship regarding the opening of registration, which became evident at the end of the summer semester. Confirming these efforts, meetings were held with the councils of the colleges, departments, and supporting deanships, culminating in the

announcement of the academic calendar for the new year. Faculty members returned to the university on Tuesday, 21 Dhul-Hijjah 1446 AH (June 2025 ,17), prior to the publication of class schedules and course registration on Saturday, 25 Dhul-Hijjah 1446 AH (June 2025 ,21).

Additionally, the university held a welcoming ceremony for new students on Wednesday, 29 Dhul-Hijjah 1446 AH (June 2025 ,25), in preparation for the official start of classes on Saturday, 3 Muharram 1447 AH (June ,28 2025).

It is worth noting that the last date for registration for the first semester is Friday, 23 Muharram 1447 AH (July 2025 ,18).

### Release of Second Issue of Journal of Economics and Business Administration

Makkah, May 2025 ,27 – The second issue of the peer-reviewed scientific journal "Journal of Economics and Business Administration," published by the College of Economics and Business Administration at the Islamic University of Minnesota, was released on Tuesday, May 2025 ,27.

The first section of the second issue includes, as in the first issue, the name of the journal, an overview, the vision, mission, and objectives, a list of the editorial board, a list of the advisory committee, a list of reviewers, a message from the editor-in-chief, and the publication rules and guidelines.

The second section features seven peer-reviewed research papers by eleven researchers. The first paper is in English, titled "The impact of work stress on job performance in Islamic banks (an applied study on Salam African Bank in the Republic of Djibouti)," which addresses the impact of work stress on job performance in Islamic banks. The remaining papers are published in Arabic, with the following titles:

6 The Implications of Fair Value Application in Financial Institutions on the Quality of Accounting Information: A Descriptive Study of Banks and Insurance Companies.

The journal serves as an important academic reference for researchers, professionals, and graduate students in the fields of economics and administration, embodying the college's vision to support impactful and innovative scientific research.

Additionally, the media center distributed the journal electronically in PDF format through all university media channels, and the technical team uploaded the issue to the official website's page for the College of Economics and Business Administration.

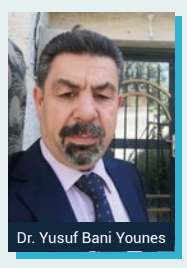

Minnesota, USA - At the conclusion of the reception for first-semester students, Saudi businessman and student Turki Al-Alimi, from the College of Economics and Business at the Islamic University of Minnesota, delivered a speech highlighting the importance of blending practical experience with academic knowledge. He explained that any businessman, no matter their achievements, needs academic knowledge to enhance their career.

Al-Alimi stressed that businessmen should not be satisfied with just a bachelor's degree; they should pursue graduate studies and continue their education through training courses, workshops, and lectures.

He began his remarks by discussing the successes he has achieved and the experiences he has gained in the world of finance and business, before explaining why he chose the Islamic University of Minnesota. He expressed gratitude for joining the university, praising its organized system and quality curriculum, and noted that he has begun applying what he has learned in his professional field.

In response to his remarks, the Director of Undergraduate Student Affairs, Mr. Sulaiman Maqbool, praised Al-Alimi for his dedication and diligence, despite his many commitments as a businessman. The director commended his character and respect for the sanctity of knowledge, confirming that he attended %98 of lectures. He encouraged all students to embody these qualities and to take inspiration from successful role models in their pursuit of education.



## Meeting of Dean of College of Development Studies with Faculty Members

The Director of the Information Technology Deanship at the Islamic University of Minnesota, Ms. Marwa Qasem Abdulwas'a, announced the accomplishments of the deanship team since the launch of the new academic system at the beginning of the summer semester, during which data for 3,064 students was uploaded.

She explained that the team entered files and data for 606 faculty members and registered 1,414 courses. Additionally, detailed grades for all students over the past three years were entered, covering more than 822 courses, with 41,878 entries for undergraduate grades and 11,796 entries for graduate grades. The team also uploaded study plans for all levels (77 plans so far) and course descriptions (342 so far).

Regarding the Admissions and Registration Deanship portal, the director confirmed that her team developed and transferred it to the new portal, enabling automated issuance of acceptance notifications and tracking of registration applications. The media center portal was also prepared to issue notifications, and a document management section was created to generate documents automatically.

Ms. Marwa added that the team developed the automated testing and grading system, allowing for the creation of customized tests, and established a smart system to save students' answers in case of internet outages. They also provided a service to send grades directly to students after MCQ tests.

The team developed the cost system to allow faculty members to send and correct costs, as well as the attendance system, which included a special system for secretaries to enter absences. A system for evaluating students on lectures and courses, as well as faculty members, was also provided, along with linking the portal to an email system to send notifications.

The director noted that these achievements resulted from 6,480 hours of work by the deanship team, consisting of four members, and 1,250 hours of work by the programming team, also consisting of four members.

In conclusion, Ms. Marwa emphasized that the development of the electronic portal is an important step toward improving the experience of e-learning and university management, reflecting the commitment of the Information Technology Deanship to provide innovative solutions that support students and faculty members.



## Achievements of the Information Technology Deanship



Makkah, May 2025 ,31 – Dr. Yusuf Mohammed Faleh Bani Younes, Dean of the College of Development Studies and Head of the Department of Development Management at the Islamic University of Minnesota, held a comprehensive meeting today with faculty members and administrative staff. The meeting aimed to enhance institutional communication and follow up on academic and administrative work.

Dr. Bani Younes opened the meeting with a welcoming speech, expressing his gratitude and appreciation to all academic and administrative staff, praising the efforts made during the summer semester, which concluded successfully without any issues. 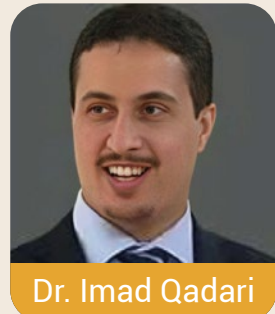
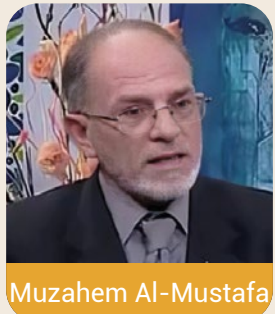

## Manuscripts and Heritage Center Holds Third Course on Manuscripts

The Manuscripts and Heritage Center at the Islamic University of Minnesota held its third scientific course related to manuscripts and investigation, featuring a select group of scholars in the field of manuscript studies from the Arab world, and managed by Dr. Sonia Salama, the center's secretary.

The course was described as a rich knowledge experience that took participants deep into the heritage and set them on the path of rigorous scientific investigation. It was an intensive and distinguished five-day course, running from Sunday to Thursday, blending theoretical and practical aspects. The course included hands-on training on the stages of investigation, from transcription to the scientific study of texts, providing a deep understanding of the components and standards of investigation under the supervision of seasoned academics. It also offered a rare opportunity for direct interaction with the lecturers, allowing participants to ask questions in interactive sessions.

The first lecture, titled "Transcription," was delivered by Associate Professor Dr. Imad Qadari Al-Ayadhi on Sunday, June 2025 ,22, at 8:00 PM Mecca time. The second lecture, titled "Stages of Investigation," was presented by Professor Dr. Muzahem Tariq Al-Mustafa on Monday, June 23, at 10:00 PM. On Tuesday, June 24, Dr. Muzahem Al-Mustafa continued the same topic with a second lecture, which was the third lecture of the course. Dr. Asmaa Farhat delivered the fourth lecture on Wednesday, June 25, at 7:00 PM, titled "The Study Section in Investigation: Definition, Components, Importance, and Standards." The course concluded with a fifth lecture by Dr. Imad Qadari Al-Ayadhi on Thursday at 8:00 PM, titled "Illuminating the Text."

It is noteworthy that the Manuscripts Center organizes these courses to harness any scientific tendencies, skills, and directions within the university community among faculty and students, encouraging them to delve into this scholarly field step by step. This is achieved by providing them with the tools to engage with the manuscript heritage in the language of the modern era, under the slogan "From Heritage We Start, and Through Knowledge We Rise," ultimately integrating them into the community of researchers who contribute to reviving the treasures of our Islamic heritage.

## English Department Announces University Textbook Project Strategy

Islamic University of Minnesota - Based on the meeting held by the English Department of the College of Arts and Humanities on Friday, May 2025 ,30, the "University Textbook Project Strategy" has been issued in both Arabic and English on June 2025 ,3.

The strategy includes a roadmap for developing the university textbook, where the "Curriculum Committee" will select the most experienced faculty member in teaching the course to undertake the task of writing the textbook under the committee's supervision. The textbook will be designed to be either theoretical or practical, depending on the course's nature. The roadmap outlines the stages of writing the book, including analyzing lectures, converting them into an academic structure, drafting content in precise academic language, adding practical components, documenting sources, and conducting scientific and linguistic reviews.

In this context, Dr. Khaled Al-Shahawi expressed hope that this strategy would serve as a model for other departments in the university.

The department also held a comprehensive meeting with a select group of faculty members,

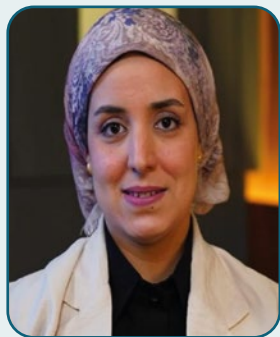
discussing several key points, including defining the reference framework for the writing process, distributing roles among members, and adopting academic standards to ensure content quality. A timeline for the various phases of the project was established, starting from planning to printing.

The meeting resulted in a set of recommendations that were formally adopted, with Dr. Suad Qassar, Chair of the Curriculum Committee, reviewing them before their official publication.

At the conclusion of the meeting, the coordinators expressed hope that this project would represent a significant step forward for the department, appreciating the efforts of faculty members involved in this important academic event.

Dr. Khaled Al-Shahawi also appointed Dr. Suad Qassar as the head of the Curriculum Unit and distributed faculty members into three specialized committees.

## Department of Creed Holds Official Meeting

On Tuesday, May 2025 ,20, at 10:00 PM Mecca time, an official meeting was held for faculty members of the Department of Creed and Contemporary Sects at the Minnesota Islamic University, chaired by Professor Dr. Imad Al-Ajili. The meeting aimed to discuss several important academic files, primarily the University Book Project.

This meeting comes in preparation for the final exams of the summer term and in line with the university administration's directives to enhance the educational process through the development of specialized academic books for each course.

The meeting reviewed the university administration's guidance regarding the preparation of a specific university book for each course. It was decided to form small committees of two to three faculty members for each course, with the names of the participants officially documented. The department head clarified that the allocated reward is symbolic, amounting to 50\$, which will be divided among the committee members.

The department head invited faculty members interested in participating to inform him of the courses they wish to work on, considering the specific specializations of each professor. He emphasized that the books should be written in a balanced scientific language, free from bias, and

according to clear academic standards.

The Curriculum Committee, chaired by Dr. Zainab Basyouni, was assigned to oversee the project, with plans to send detailed guidelines for authorship (such as page numbers, general structure, and writing style) through the department's group after the meeting. The committee will also review the content to ensure it aligns with university standards.

The meeting featured multiple interventions from faculty members, focusing on authorship guidelines, intellectual property rights, task distribution within the committees, and coordination methods with the Curriculum Committee. It was confirmed that all materials are available for participants to choose from based on their academic specializations.

The attendees agreed on the importance of this project in reinforcing the scientific identity of the department and enhancing the quality of academic content provided to students. The meeting concluded with several recommendations, including an invitation for those interested in participating to submit the names of the courses within two days of the meeting, along with thanks to Professor Anisa Al-Zakri, the administrative affairs officer of the college, and the department secretary for their efforts in facilitating administrative work.

This meeting, which lasted over two hours, is part of the intensive preparations carried out by the university before the start of the first semester of the new academic year and prior to each semester.

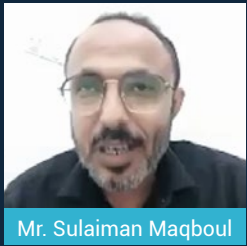

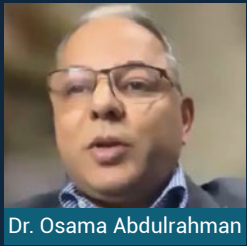

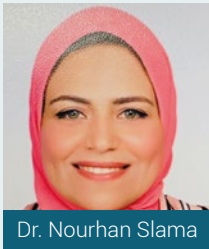

The fourth topic discussed was the preparation of the university textbook, with a decision made

to hold a special session next week to discuss and approve the plan. The fifth topic involved the proposal for the student academic forum, which aims to develop academic student activities and organize workshops. The proposal was officially approved.

Regarding the second technical camp, it was approved to be held at the end of next week, consisting of four specialized workshops aimed at all university students and interested individuals from outside the university. This camp is considered the first official event under the college forum.

The meeting concluded with an open floor for comments and inquiries, where department heads discussed various questions related to academic descriptions, schedules, and inter-departmental coordination. The college vice dean was tasked with preparing to establish a specialized training center to support the technical and research skills of faculty members and students.

The meeting resulted in several key recommendations, including:

- 1- Approving new appointments related to the committees.
- 2- Implementing the second technical camp.
- 3- Forming a supervisory committee to manage the forum.
- 4- Inviting the university textbook committee to hold a special meeting.
- 5- Continuing to monitor the performance of deputy department heads.
- 6- Submitting a memorandum to senior management to activate incentives from training course revenues.
- 7- Tasking the college vice dean with preparing a proposal for establishing a specialized training center for the college.

Attendees included the college vice dean, heads of departments, and the college director, Ms. Hanadi Abdullah, who recorded the meeting minutes

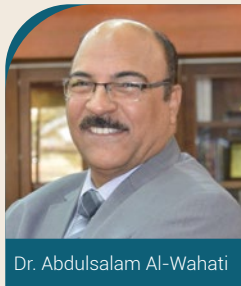
## Important Meeting at the College of Media

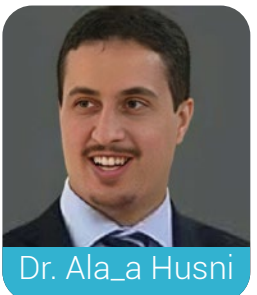

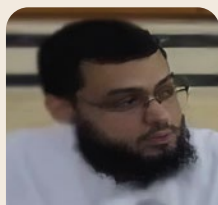

## Academic Meeting in Department of Hadith and Its Sciences

universities and adapting them instead of starting from scratch. They stressed the importance of establishing precise standards for textbook authorship that balance academic authenticity with contemporary requirements.

Additionally, the meeting addressed other educational and administrative aspects, including monitoring grade reporting and correcting summer semester exams, as well as students' weak research writing skills, which necessitate intensified academic guidance. Recommendations included granting incentive grades to encourage student engagement and proposing the preparation of a simplified research writing guide for students, featuring models and practical assignments.

At the end of the meeting, attendees came up with several recommendations, including forming a small committee within the department to coordinate with the central curriculum committee and opening the door for faculty members interested in volunteering for authorship and review processes. It was emphasized that the work of authoring the university textbook is considered a beneficial scientific voluntary effort, not mandatory.

The meeting concluded with prayers for everyone's success and a reaffirmation of the importance of collaboration to ensure the success of this academic project, enhancing the quality of education and serving the interests of students.

The meeting focused on several topics, including the necessity of receiving courses without delays, preparing educational materials, ensuring attendance and interaction, and rejecting late excuses.

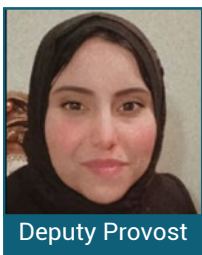

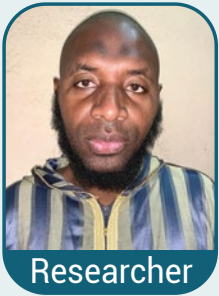

### Doctorate Awarded to Researcher Abdulrahman Halifa Sado



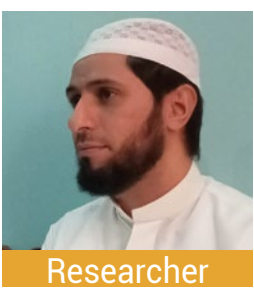

This achievement is part of the university's support for researchers and the enhancement of scientific research in the field of Islamic studies.

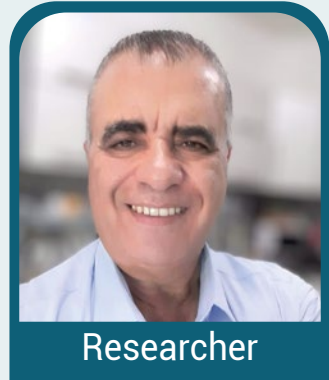


### Research Plan Approved for Researcher Awad Al-Qarhi

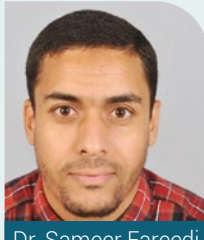

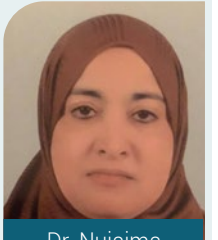
Participants who completed the course received accredited certificates from the Training Center, with a link provided to access the certificates through the university's official website after the program concluded.

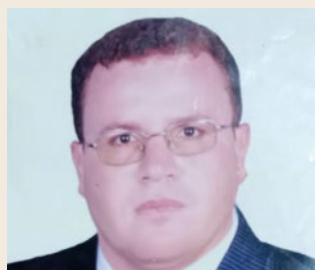
## Training Course on Islamic Translation

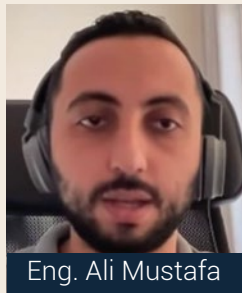
The attendees discussed challenges faced by faculty members, such as delays in student submissions, high enrollment in shared summer courses, and issues arising from the new system.

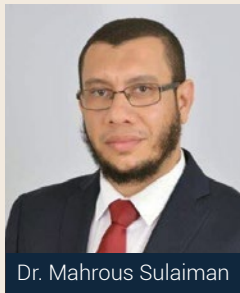

Fifteen faculty members attended the meeting, while some were unable to join due to travel commitments.

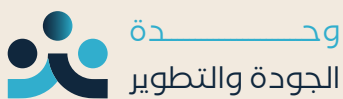

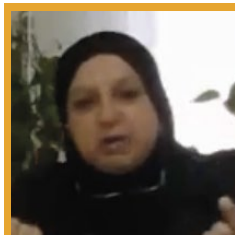

It is noteworthy that the Quality Unit awarded certificates accredited by the university to the committed attendees.



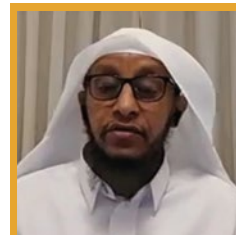

# Women: Hidden Power in Building Communities



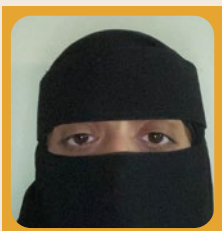
